RECOMMENDATION

That the Accessibility Advisory Committee receive and file this communication.

BACKGROUND

The Public and Catholic School Boards (School Boards) are moving forward with the design of a new joint-use school at the site of the current Imperial School at 160 Broad Street. This new school will replace Imperial, McDermid, St. Peter and St. Michael Schools (Appendix A). The City of Regina (City) has had a lease with the Public School Board since 1994 for a portion of Imperial School, which houses the North East Community Centre (the NE Centre). The NE Centre is operated by the community and provides space for the North East Community Association and others to deliver valuable programs and services to the community. The community centre space currently contains office space for the Community Association and Centre boards, a reception area, washrooms, three smaller programming rooms and a larger multi-purpose room.

Administration is collaborating with the School Boards on the project to include a replacement community centre within the new building. The consultant team hired for the project and Administration will be sharing a presentation on the preliminary design, in order to gather feedback from the Accessibility Advisory Committee the accessibility of the Centre. This information will help inform the design of the community space that is constructed as part of the joint-use facility.
