Globe Mortgage

Globe holds a mortgage of \$866,500 with monthly payments of \$6,636

Enhanced Accessibility

The cost for the enhanced accessibility has not been broken out from any budget or contractor submissions. As a result, the following are approximate costs for information purposes.

- \$ 230,000 Elevator (The building now has three elevators, the original had one)
- \$ 50,000 Lift to Community Theatre Control Room and added space
- \$30,000 Electronic hardware
- \$ 30,000 Washroom layouts and additional space
- \$ 30,000 Dressing room layouts and additional space
- \$ 40,000 Technology for hearing impaired and misc. other upgrades
- \$ 410,000 Total Enhanced Accessibility

Note that this does not include new Scarth Street entrance way steps or ramp, without which the building accessibility is compromised.

Structural Assessment (further detail is provided in the included letter from James Youck)

A deconstruction of building finishes to examine the condition of the structure was not conducted. To do so would have required significant demolition of interior finishes such as ceilings, existing plasterwork, concrete fireproofing, and terrazzo floors. None of this is appropriate in an occupied building and it was only with full demolition that the issues were uncovered. The original main vertical steel structure that remains post demolition has not required significant additional support. The majority of unforeseen structural challenges have been a result of holes in the floor that were previously covered, unsupported masonry from previous interventions over the last 100 years, and failed concrete slabs. The latter was most acute at the roof where the concrete was covered with a roof material and membrane. Upon demolition many sections of the concrete pulled away and remained attached to the membrane.

RE: Globe Theatre Project, Presentation to City Council James Youck, Architect, Principal SAA, AAA, FRAIC, AIA International

The Globe Theatre funding request is because of the extraordinary factors that have resulted in cost increases for this important project.

These include the following:

- Project estimating for initial funding requests was prepared pre-pandemic.
- The post pandemic escalation and inflation factors have been exceptional and could not have been foreseen. Construction costs across the industry have increased by 25-50%. This is not an issue that is temporary in nature. The labour market has tightened, and material costs are unlikely to change significantly in the near or distant future.
- The design team is experienced with projects involving heritage buildings. As demolition of the building was conducted it became apparent that the state of the Prince Edward Building was far worse than would have been expected. This is due to two primary issues, firstly, the original construction was of poorer quality than other contemporary buildings, and secondly the 100 years of churn and change of use had resulted in deterioration of the structure which was hidden behind layers of interior finishes such as drywall and plaster. The net result was an additional \$2m in structural intervention required to stabilize the building.
- To accommodate as much of these costs as possible funds were moved from contingencies and from exterior restoration into the interior structural work.

Design commentary:

- The Globe Theatre design takes the function of the theatre into the 21st Century. It will be a world class facility, and has features that any modern theatre would expect, but were not previously present. These include:
 - a trap room beneath and a catwalk system above the mainstage. This allows for increased flexibility when designing performances but also enhances the safety of the facility for staff and performers;
 - o an updated seating bowl where every seat is oriented towards the stage, seats are wider, and leg room increased for comfort;
 - improved patron and actor/back-of-house separation where audience members no longer cross the stage to access seats, and the inclusion of a "run-about" for actors and staff to access the stage. This is the back-of-house in a theatre in the round.
- The evolution of the Globe Theatre from a "private" building or space to a community focused theatre on the Scarth Street Mall has been accomplished in this design.
 - A community theatre, the 2nd stage or "black-box" is located on the main floor and has been designed to be a multi-purpose theatre space. It was previously located on the upper level. The lobby, black box theatre, and control room can be separated from the



- remainder of the theatre areas allowing the space to be used in off-theatre hours and seasons without compromising security.
- The Theatre School likewise has moved from the upper level to the lower level where it is accessible from the new elevators and the grand staircase. This increases access to the spaces during off-theatre hours.
- The box office has moved from the upper floor down to the main floor lobby. The design, at the urging of the Globe Theatre, has created a "public living room" along the main level Scarth Street side. This lobby, with coffee area, box office, and community theatre lobby provides an open, public space off of Scarth, animating the prominent corner of Scarth and 11th Ave.
- The Globe has been designed with accessibility in mind. Over \$400,000 was spent to ensure that accessibility for actors and patrons is enhanced. This includes the washroom and dressing room design, the community theatre control booth is accessed via a dedicated lift system, and additional elevators were included to provide access to all levels of the building for patrons and actors. Accessible seating in the mainstage provides patrons with options for their ticket locations. Enhanced acoustics and sound systems will provide access to performances for the hearing impaired.

Additional challenges:

- At this time, the existing stairs and ramp located on Scarth Street, are City property. We believe
 built by the City as part of previous Scarth Street rehabilitation project. These were in a state of
 disrepair when our project started and do not meet current codes.
 - The original design of the stair and ramp does not represent a welcoming and universally accessible entrance for the Globe. There is risk that due to the design and the condition they will not be safe for public use without some significant investment.
 - The replacement stairs and ramp will meet all codes and will provide a stage like presence along Scarth St. This will be a feature along, what will eventually be, a revitalized Scarth Street.

Re: Augmented Funding for the Globe Theatre

I am writing as the Chair of the Steering Committee for On Cue Performance Hub, Regina's newest performing arts organization. As an organization which emerged out of grassroots public meetings of local performing artists and community members in 2019, On Cue is bound by its mandate

- To make it more possible for local artists to earn a living from their creative practice and in particular enable the diversity of emerging and underserved local artists to find a place on Regina stages;
- 2) To cultivate equally diverse community engagement and support for the work of On Cue artists and companies; and
- 3) To increase the availability of accessible and affordable spaces suitable for the needs of performing artists and cultural professionals, especially professional quality performance spaces.

From early on in our history and especially during our first performing arts season in 2021, the Globe Theatre has reached out to our organization as a Senior Supporting Partner and in support of our local artists and small companies. This is an indication of the wider role this organization plays in our arts and performing arts community. It is a keystone organization in Regina's arts ecosystem. The significant number of artists and arts professionals that it employs full time contribute to the backbone of our professional artist community and serve as vital colleagues for other independent artists working in the community.

The Globe's past and future are closely tied to the iconic theater space which it is upgrading—but their renovated space is also deeply connected with the future of other performing arts organizations like ours. Council will be aware of the detailed and substantial performing arts space study for the City that On Cue Performance Hub worked with city staff to provide in 2021. That study demonstrated in considerable detail what every performing arts organization in the

City knows full well—that the City lacks sufficient professional quality performing arts facilities to serve its local artists. In the context of renovating its facilities, it should be remembered that the Globe has undertaken to create a second performance space which it intends to make available to other local performing arts organizations like ours. This will in no way fully address the lack of adequate facilities elsewhere in the City, but if the Globe continues to struggle financially to complete its renovation project it certainly will not be able to carry through with its efforts to help with the problem.

For anyone who has ever attempted to renovate an old building and discovered once the framework was laid bare that things were not in as good a shape as one might have hoped, and for many more people who have simply watched the costs of paying for anything rise steadily over the past couple of years, this request for additional funding from Council should be immediately understandable.

We urge Council to approve this recommended allocation. This will be a life-line to an arts organization that is critical to the fabric of our arts ecosystem and one that has demonstrated its capacity to attract further funding and business to our City. Additionally, this is an organization which has undertaken a massive project to rehabilitate one of Regina's important heritage buildings in its downtown core—a building which at one point housed City government and the Council itself and therefore a building for which Council in particular should feel some sense of responsibility.

It gives me great pleasure to send this written submission in support of the Globe Theatre's request from city council for an additional \$1.98 million to complete their renovations. My name is Sierra Haynes. I am an emerging artist that the city of Regina, more specifically an artist that The Globe Theatre nurtured and inspired—and now has employed as a theatre professional! I am in favour of you extending funding to the Globe's campaign.

The Globe theatre is one of Canada's most unique professional theatres. Artists from across the country want to work at the theatre because of its uniqueness. The Globe is the only permanent, year-round, theatre in the round in the country! Because of this the work created on the stage remains memorable and intimate for both audience and cast in a way that is truly only a gem that Regina can say it has.

On a personal level, I started as a student at the Globe Theatre School when I was about 10-years-old. The unique pedagogical approach that the Globe champions in teaching its students to be brave and bold on stage stems from its concentration on devising new-work. This has become one of the most critical skills that I could have nurtured at such a young age to affect my professional career in the arts now. It made me confident to say what I meant, to artistically disagree, to collaborate, to see something through from start to finish. It made theatre school auditions fun; it made post-secondary theatre school less "personal" (and by that I mean I'd been hearing critiques on my thoughts and work since an early age, so I'd already learned not to take everything so seriously).

I was easily the youngest person in the 5 person ensemble by probably 15 years...and I totally held my own in that space. My collaborators, yes, were generous and kind. But I leaned A LOT on what I learned as a GTS student. For this show we were nominated in 7 Dora Mavor Moore Award categories, and we took away three. 2 awards of which I get to keep on my mantle to be proud of. I would not be an award-winning theatre artist without the example, leadership, expertise, and love that The Globe Theatre poured into me growing up.

The theatre opens minds and changes hearts. Please allow this tradition of excellence to continue. I am very proud to be a Regina-native, and often come back to work in the city. Wherever I go, I'm a proud prairie-girl who loves the cando, resilient nature of our communities.

Finally, I would like to speak to the leadership that the theatre currently has.

Jennifer Brewin and Jaime Boldt are absolutely the people that will usher in a new era for Regina in our theatre space. Jaime Boldt loves her community and has great business sense. She's a champion for women in business and I admire her tenacity and work-ethic to continue to bring the arts to our community.
