The report informed Finance and Administration Committee of the information to be used in preparing *The Regina Property Tax Bylaw, 2019* and *The Education Property Tax Bylaw, 2019*. At the April 17, 2019 Executive Committee meeting the Regina's Warehouse Business Improvement District submitted EX19-16 - Regina's Warehouse Business Improvement District - 2019 Budget for consideration. The budget contains a mill rate of 0.50396 mills. The Executive Committee forwarded EX19-16 for City Council approval at the April 29, 2019 meeting.

#### **Regina Downtown Business Improvement District**

At the April 17, 2019 Executive Committee meeting the Regina Downtown Business Improvement District submitted EX19-15 - Regina Downtown Business Improvement District -

2019 Budget for consideration. The budget contains a mill rate of 0.5997 mills. The Executive Committee forwarded EX19-16 for City Council approval at the April 29, 2019 meeting.
