BYLAW NO. 2022-18

THE REGINA ANIMAL AMENDMENT BYLAW, 2022

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The purpose of this Bylaw is to amend Bylaw 2009-44, being *The Regina Animal Bylaw*, 2009, to add three off leash dog parks.
- 2 The authority for this Bylaw is subsections 8(1), 8(2) and 8(3) of *The Cities Act*.
- 3 The Table of Contents is amended by striking out "Schedule "B" Map Designating Area as an "Off Leash Dog Park"" and substituting the following:

"Schedule "B" Off Leash Dog Parks

Schedule "B.1" Seasonal Off Leash Dog Areas"

- 4 Schedule "B" is amended by adding the map attached as Appendix "A" Horizon Station Park.
- 5 Schedule "B" is amended by adding the map attached as Appendix "B" A.E. Wilson Park.
- 6 Schedule "B.1" is amended by adding the map attached as Appendix "C".
- 7 Section 4 of this Bylaw comes into force on July 1, 2022. Section 5 of this Bylaw comes into force on October 1, 2022. Section 6 of this Bylaw comes into force on May 1, 2022. The remainder of this Bylaw shall come into force on the day of passage.





Appendix "A" Horizon Station Park




KELLER AVENUE
