7. What is your organization's mandate?

The mandate of "The Trial of Louis Riel", is to strive to continue to produce and share telling the story of the most remarkable person in Metis history and this important historical and cultural event that profoundly influenced Canadian society and politics, the founding of Manitoba, and the rights of Western Canadians, particularly in Saskatchewan and the development of Regina, for continuing generations of the school population and the public.

8. What are some of the significant accomplishments and successful programs of your organization over the past 3 years?

Some recent successful accomplishments have been to tour "The Trial of Louis Riel, to Ottawa and Cornwall, ON, Vancouver, BC, Winnipeg, MB, twice, and Pinehouse, SK. Additionally, we did a "Special Performance" in bringing back all the former actors who have played Louis Riel and making them members of the jury has been a highlight of the production.

PROGRAM MERIT:

'The Trial of Louis Riel 50th Anniversary Reunion will entail a weekend of activities. The anticipated and preliminary dates planned now are for early June as part of celebrations to kick off the Aboriginal History Month.

The venue locations for the weekend event are still being examined and negotiations are ongoing. The Conexus Arts Centre is the current front runner and preferred venue. Whatever becomes the final selection will be primarily determined by their accessibility and ability to accommodate the public of the community of Regina.

The weekend activities planned for "The Trial of Louis Riel 50th Anniversary Reunion", will include a command performance of a re-emactment of "The Trial of Louis Riel", as well as a catered banquet welcoming, honouring, and celebrating all those who have acted or participated in some fashion over the past 50 years with "The Trial of Louis Riel".

The event will also support the bringing back of all those major characters who have played Louis Riel over the past 50 years and engaging them in the "command performance", as jurors or other players in the production.

Additionally, professional actors will be retained for the further embellishment and to add to the professionalism of this once in a lifetime, halmark, achievement and historical moment in time.

COMMUNITY NEED

At this time it's too early to be able to tell which other partners will be coming to participate and support "The Trial of Louis Riel 50th. Anniversary Reunion". However, we will in due course, as deadlines become known, be applying to other programs and making sponsorship proposals to other public and private businesses.

COMMUNITY IMPACT

12. What is the direct community impact of this event?

Both the direct and indirect impact of "The Trial of Louis Riel 50th Anniversary Reunion", will be enormous. The direct impact of the event on Regina and surrounding community will be to heighten a greater pride and understanding of the Metis history in particular and that of all of the rest of us, generally. To be sure, it will shine even more light and bring greater clarity to the greatest of all Metis leaders, Louis Riel and a better understanding of the political, economic, and social circumstances of that era and event.

This impact will also be felt indirectly not just in SK, but also MB and other communities throughout Canada, which will feel the summons to attend this significantly, seminal, moment in history.

Finally, the educational impact "The Trial of Louis Riel 50th Anniversary Reunion", will have will be enormous. It will not only attract a whole new generation of educators and students to this important historical moment in time of our collective consciousness, but it will help propel that interest and significance of this event for everyone for the next 50 years creating a great legacy for the future.

13. How will you measure success of the event?

Success of "The Trial of Louis Riel 50th Anniversary Reunion", will be greatly measured by the number and amount of funding support that we achieve to carry off this momentous, landmark, iconic, achievement.

Additionally, success will also be measured in the attendance and gross revenue as factors to contribute to the overall economic impact of this historic event.

14. What is the anticipated attendance of the event?

The anticipated attendance of "The Trial of Louis Riel 50th Anniversary Reunion" is 500. However, we anticipate related to this overall particular event the spin off results for the "school shows", "summer shows', and any other possible one-offs and touring opportunities to reach out to upwards of an additional 10,000 individuals.

15. Provide your best estimate of the economic impact of the event (e.g., ticket revenue, number of people employed)?

If adequate funding is secured in line with our projections, the best estimate of the number of actors and individuals employed for, "The Trial of Louis Riel 50th Anniversary Reunion", will be 50, many of whom will be professional actors recruited especially for this landmark occasion.

Also, if expectations can be met through secured funding for marketing, venues, and personnel it's anticipated that there could be a gross of \$40,000 in ticket revenue.

ACCESSIBILITY

"The Trial of Louis Riel 50th Anniversary Reunion", is available to all sectors and strata of society, regardless of physical abilities or socio-economic background. The production will take place in a public forum that will be accessible to anyone from the public, which includes accessibility for wheelchair participants.

Additionally, fees will be set that make viewing of the performances emininently affordable for everyone from all groups and individuals in the socio-economic component of our society, allowing anyone the ability to view and honour this landmat, iconic production.

There will even be a "free' component to this special event.

17. Describe how this program is accessible to the public? Please specify, which aspects of the event are free and which have an admission fee? List all levels of applicable fees.

"The Trial of Louis Riel 50th Anniversary Reunion", will be completely accessible to the public since it will be advertised and marketed as an open public event and will take place in a convenient, centrally located public facility. The level of fees will be the same as for all of the regular performance shows of the production, namely, Adult, Student, and Youth.

The performances will be "free" to children 6 and Under.

FINANCIAL NEED

18. Explain why funding from the City of Regina is needed?

Funding from the City of Regina is required to celebrate the 50th. Anniversary & Reunion of the "The Trial of Louis Riel". This is the most important event in the history of this cultural icon, which is the longest running dramatic theatrical production in North America.

"The Trial of Louis Riel", began as a Centennial Project in 1967 when the City directed the Chamber of Commerce, as part of the City, to commission a work by John Coulter to write the play based on the actual transcripts of the famous trial in Regina from 1885 of Louis Riel for which he was tried for treason and hung in Regina, for the purpose of celebrating the Centennial.

It would only be fitting for the City of Regina, which mounted this as a Centennial Project in the 1st. place, to participate in honour of the Celebration of this momentous, landmark, historic, occasion.

Support of this endeavour is essential to carry out this project and assure the continunity of the production of this iconic, story of our culture and shared history.

APPLICATION AGREEMENT

Use of Money

We hereby strongly endorse the request of RielCo Productions for funding a 2017 Reunion of the play "The Trial of Louis Riel" (the Play) in honor of Canada's 150th Anniversary and the 50th Anniversary of the presentation of this memorable Play.

Because of these two noteworthy Anniversaries, the year 2017 will be highly significant for both Canada and the Louis Riel Play.

As a nation, Canada has a rich and fascinating history and heritage. Among the most exciting and inspiring highlights in the struggles of the Métis was a fight for basic human rights and democracy. They achieved these and other results including provincial status for the Prairie Provinces, thereby contributing to the Canadian Confederation. After the Red River Resistance of 1869-70 led by Louis Riel, Manitoba was made a province of Canada on July 15, 1870.

The valiant efforts of the Métis during the North-West Resistance of 1885 achieved a similar result and Saskatchewan and Alberta eventually became Provinces of Canada in 1905. Regrettably the Resistance also resulted in the 1885 trial and execution of Louis Riel for high treason. In 2010 the Province of Saskatchewan to recognized the "significant, vibrant and distinct culture" of the Métis.

It was the Métis, under the leadership of Louis Riel and Gabriel Dumont (the great buffalo hunter and military strategist), that led to these Métis achievements. The play "The Trial of Louis Riel" is a means of keeping alive these memorable Canadian historical events. The Play's Reunion in 2017 would be a great opportunity to share with the Canadian public this important aspect of Saskatchewan's and Canada's history and heritage.

RielCo Productions will require funding in order to accomplish its objective of recognizing in a significant way the heritage and culture of the Métis of Saskatchewan and Canada with the play "The Trial of Louis Riel". Accordingly we support Rielco's application to you for financial resources to assist them in accomplishing these admirable objectives in 2017.
