

BYLAW NO. 2020-7

THE EMERGENCY MEASURES AMENDMENT BYLAW, 2020

---

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The purpose of this Bylaw is to amend the membership of the Local Emergency Planning Committee to align with the membership of the City’s Emergency Operations Centre.
- 2 The authority for this Bylaw is section 9 of *The Emergency Planning Act* and sections 8 and 55 of *The Cities Act*.
- 3 Bylaw 2011-37 is amended in the manner set forth in this Bylaw.
- 4 Section 3 is amended by striking out “Emergency Management and Business Continuity Branch” and substituting “Emergency Preparedness and Business Continuity Branch”.
- 5 Section 4 is amended by striking out “Manager of Emergency Management and Business Continuity” and substituting “Manager of Emergency Preparedness and Business Continuity”.
- 6 Section 6 is repealed and the following substituted:
  - “6. There is constituted, established and continued a local emergency planning committee for the City, which shall consist of persons holding the following positions or their designate:
    - (a) City Manager;
    - (b) Manager, Emergency Preparedness & Business Continuity;
    - (c) Executive Director, Citizen Services;
    - (d) Director, Citizen Experience;
    - (e) Executive Director, Financial Strategy & Sustainability;
    - (f) Executive Director, City Planning & Community Development;
    - (g) Director, Fire & Protective Services;
    - (h) Director, Sustainable Infrastructure;
    - (i) City Solicitor; and
    - (j) Chief of the Regina Police Service.”
