THE COVID-19 PANDEMIC AMENDMENT BYLAW, 2020

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

**Purpose**

1 The purpose of this Bylaw is to amend *The Covid-19 Pandemic Bylaw, 2020* to alter the timelines and requirements in various City of Regina bylaws in response to the public health emergency.

**Authority**

2 The authority for this Bylaw is section 8 of *The Cities Act*.

**Bylaw 9635**

3 Clause 3(a) is amended by striking out “June 30, 2020” and substituting “July 31, 2020”.

4 Clause 3(c) is amended by striking out “June 30, 2020” and substituting “August 31, 2020”.

5 Clause 3(f) is amended by striking out “June 30, 2020” and substituting “July 31, 2020”.

**Bylaw 9881**

6 Section 4 is amended by striking out “June 30, 2020” and substituting “July 31, 2020”.

**Bylaw 9900**

7 Section 5 is amended by striking out “until June 30, 2020” and substituting “as long as is reasonably necessary to respond to the public health emergency”.

8 The following section is added after section 5:

“5.1 Notwithstanding the fees outlined in Bylaw 9900, being, *The Regina Traffic Bylaw, 1997*, the City Manager or designate shall have the authority to waive fees or charges for street use permits for as long as reasonably necessary to respond to the public health emergency for the following uses:

- (a) Mobile food Vending Unit as defined in *The Clean Property Bylaw*; and
- (b) Outdoor Restaurant as defined in *The Clean Property Bylaw*.”

**Bylaw 2009-44**

9 Subsection 8(1) is amended by striking out “June 30, 2020” and substituting “July 31, 2020”.

10 Section 10 is amended by striking out “June 30, 2020” wherever it appears and in each case substituting “July 31, 2020”.
