THE REGINA ZONING AMENDMENT BYLAW, 2020 (No. 20)

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The purpose of this Bylaw is to permit residential short term accommodation, subject to a licensing requirement.
- The authority for this Bylaw is sections 46 and 49 of *The Planning and Development Act*, 2007.
- 3 Schedule "A" of Bylaw 2019-19, being *The Regina Zoning Bylaw*, 2019 is amended in the matter set forth in this Bylaw.
