Re: Waste Vegetable Oil Conversion

WHEREAS, the transformation of waste vegetable oil into clean energy is a "green" solution.

THEREFORE BE IT RESOLVED, that the Public Works and Infrastructure Committee request the City Administration provide a report to the Public Works and Infrastructure Committee in the third quarter, which includes options for feasibility and local design of a waste vegetable oil conversion system such as the vegawatt system which could be used for a pilot project in 3 locations that have a minimum of 2 deep fryers such as Evraz Place, University of Regina and 1 independent restaurant.
