CR24-4 Housing Incentives Policy – 2024 Updates

Recommendation

That City Council:

- 1. Approve amendments to the City of Regina *Housing Incentives Policy* (HIP), as outlined in this report with the specific wording changes in Appendix C, which are generally summarized and described as follows:
 - a) Allow conditional funding commitments earlier in project development to proactively support affordable housing

developments;

- b) Increase flexibility in reporting of affordable units to reduce vacancies and decrease administrative complexity;
- c) Allow unallocated HIP funds from previous years to be committed under the HIP in subsequent years where applications exceed the annual HIP budget;
- d) Update the Design and Development Criteria Scorecard, including to expand the list of vulnerable groups to align with the National Housing Strategy;
- e) Transfer Executive Director authorities in the policy to the City Manager to reflect changes to administration area;
- f) Allow the City Manager, or designate, to make minor substantive changes to the policy where a specific provision conflicts with the program objectives;
- g) Allow the Director responsible for housing to make housekeeping amendments to the policy;
- b) Delegate some authorities from the executive level to the Director and Branch Manager, responsible for housing, to streamline approvals for business-as-usual decisions;
- i) Amend policy language to improve clarity and administration of HIP, as outlined in Appendix D; and
- 2. Direct Administration to prepare a quarterly communication memo to Executive Committee on any policy amendments pertaining to the delegated authority outlined in 1. f) and g).

 - a. Utilize a collaborative and facilitated approach to the work the City performs in North Central to facilitate inter-departmental planning, and to coordinate municipal work to achieve the outcomes of the neighborhood revitalization plan as defined by the North Central Strong task force;
 - b. Hold any properties that the City takes title to through the tax enforcement process (This is allowed within The Tax Enforcement Act) and provide these property addresses to the North Central task force to

be considered for housing opportunities - either a rent to own program or for affordable rental;

- c. Facilitate the development of a community land trust, and consider holding North Central land in the interest of the local community, and to ensure access to affordable housing;
- d. Collaborate with Indigenous-owned enterprises, Indigenous leaders and Nations, a municipal land development entity, and with other development companies to facilitate housing revitalization initiatives;
- e. On an ongoing basis, utilize youth-led community engagement as part of the learning process for the City of Regina and a model to make space for voices not often engaged;
- f. Ensure continued operations of the Housing Standard Enforcement Team, and utilize the Building Standards Act to address distressed, dilapidated, and unsafe buildings;
- g. Pursue all opportunities to increase land holdings in the community land trust/land bank;
- h. Continue focused demolition of unsafe properties;
- i. Work collaboratively with the Regina Police Service to develop focused crime reduction techniques;
- j. Create opportunities for philanthropy and private businesses to invest in youth, public art, sports, and art development projects; and
- k. Work with the South Saskatchewan Community Foundation to establish a City of Regina Community Fund (with a specific focus on North Central renewal projects) through the dedicated to raising funds, both legacy (endowed) and flow- through (non-endowed), for specific projects or purpose.
