The purpose of this report is to facilitate the appointment of a citizen member to the Regina Planning Commission.

The Regina Planning Commission advises and assists City Council with respect to all matters pertaining to community planning and development. The Commission has the duties and powers as set forth in <u>The Planning and Development Act, 2007</u> and The Committee Bylaw, No. 2009-40. The terms of the citizen members are staggered, up to three-year appointments.

#### DISCUSSION

Executive Committee is required to nominate individuals for City Council consideration on the Regina Planning Commission. In preparation for the appointment the vacancy was advertised inviting citizens to apply for the position on the board and were placed in the Leader Post on May 12, 2018 and on the City of Regina website. The deadline for applications was Monday, May 21, 2018.
