Terms of Reference

Composition

Committee Bylaw, Schedule B, Table 9, s. 3 Committee Bylaw, s. 19, 20 The Committee is authorized to discuss issues of mutual interest and concern to both parties.

The Committee consists of 12 members appointed by resolution of Council as follows:

- (a) the Mayor;
- (b) two members of Council;
- (c) the City Manager;
- (d) four representatives of Regina Public School Board; and
- (e) four representatives of Regina Catholic School Board.

Other than the City Manager, no employee of the City of Regina or Regina Police Service is eligible to be a member of the Committee. Members are appointed in accordance with the procedures for appointments set out in The Procedure Bylaw.

Term

Committee Bylaw, Schedule B, Table 9, s. 4 Committee Bylaw, s. 27 The Mayor, the Council members and the City Manager are not eligible to vote.

The Mayor is the chair of the Committee.

- 1) The Mayor and the City Manager are ongoing members of the Committee.
- 2) The Council members hold office for up to three-year staggered terms as may be set by resolution of Council.
- 3) The remaining members hold office for up to three-year staggered terms as may be set by resolution of Council, subject to a maximum of nine consecutive years.
- Committee members whose terms have expired will continue as members until such time as Council re-appoints the member or names a successor.
- 5) A vacancy that occurs during the year will only be filled where there are three or more meetings in the unexpired portion of the term of the person being replaced. All other vacancies may be filled for the unexpired portion of the term of the person being replaced by the appointment by Council of another eligible person.

The Committee meets at the call of the chair.

Special meetings may be called by the chair or the City Clerk, when requested in writing by a majority of the Committee.

Quorum

If quorum is lost during a meeting the meeting shall stand adjourned.
