THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The purpose of this Bylaw is to amend *The Noise Abatement Bylaw*, 6980, by adding a voluntary payment amount for Motor Vehicle noises.
- 2 The authority for this Bylaw is section 8 of *The Cities Act*.
- 3 Bylaw No. 6980, being *The Noise Abatement Bylaw*, is amended in the manner set forth in this Bylaw.
- 4 Subsection 11(b) is repealed and the following substituted:
 - "11(b) Pursuant to section 10 of *The Summary Offences Procedure Act, 1990*, where a Summary Offence Ticket Information is issued for a violation of clause 3(i), 4(A) or 6(d) of this Bylaw, the peace officer may enter on the ticket the following voluntary payment amounts:"
- 5 Subclause 11(b)(i) is amended:
 - (a) by striking out "and" after subclause (i);
 - (b) by adding the following subclause after subclause (i):
 - "(i.1) For clause 4(A) two hundred and fifty dollars (\$250.00) plus any applicable surcharge imposed pursuant to *The Victims of Crime Regulations*; and"
- 6 This Bylaw comes into force on the day of passage.
