BYLAW TO PROVIDE FOR THE CLOSURE OF A PORTION OF
LANE L1, PLAN 101891695 AND LANE 327, PLAN OLD 33, EXTENSION 1

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

1 The purpose of this Bylaw is to close a portion of the road right-of-way.

2 The authority for this Bylaw is section 13 of *The Cities Act*.

3 The lane described as follows is closed:

“All that portion of the right-of-way shown on the map attached as Appendix “A” and described as being a portion of Lane L1, Plan 101891695, Extension 0, and St/L 327, Plan OLD 33, Extension 1.”

4 This Bylaw comes into force on the day of passage.

BYLAW TO PROVIDE FOR THE CLOSURE OF A PORTION OF
LANE L1, PLAN 101891695 AND LANE 327, PLAN OLD 33, EXTENSION 1

PURPOSE: To close a portion of Osler Street between 11th Avenue and Saskatchewan Drive.

ABSTRACT: The proposed closure will allow the consolidation of the lane with adjacent properties to accommodate the land assembly required for the expansion of the Regina Police Service headquarters.

STATUTORY AUTHORITY: Section 13 of *The Cities Act*.
