THE REGINA TRAFFIC AMENDMENT BYLAW, 2018 (No.5)

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The purpose of this Bylaw is as follows:
 - (a) to amend Bylaw 9900, being *The Regina Traffic Bylaw*, 1997 to:
 - (i) establish new fee categories for City parking permits; and
 - (ii) provide for mobile food vending permits with or without meter bags; and
 - (b) make consequential amendments to Bylaw 9881, being *The Regina Clean Property Bylaw*, 1997, to provide for the options outlined in subclause (a)(ii).
- 2 Schedule "J" of Bylaw 9900, being *The Regina Traffic Bylaw*, 1997, is repealed and the attached Schedule "J" substituted.
- 3 Bylaw 9881, being *The Regina Clean Property Bylaw*, 1997, is amended in the manner set forth in sections 4, 5 and 6 of this Bylaw.
- 4 Section 10.1 of Schedule "K" is repealed and the following substituted:
 - "10.1 An approved vendor may elect to purchase a permit that includes a parking meter bag. The parking meter bag allows the vendor to bag any available meter that meets the criteria set out in these Regulations and operate a Mobile Food Vending Unit from that location."
- 5 Section 10.5 of Schedule "K" is amended by striking out "applicable".
- 6 Section 18.1 of Schedule "K" is amended by striking out "and parking fees".
- 7 This Bylaw comes into force on the day of passage.
