



THE PROPOSED AREA OF DEVELOPMENT FOR THIS APPLICATION ONLY INCLUDES THE ADJACENT AREA AROUND THE MUNICIPAL JUSTICE BUILDING, AS SHOWN ON THE LANDSCAPE SITE PLAN.

IT IS ALSO IMPORTANT TO NOTE THAT THE MAJORITY OF THE PARKING STALLS ARE ASSIGNED FOR STAFF AND FLEET VEHICLES AND THEREFORE HAVE BEEN NOTED AS PRIVATE PARKING LOTS ON THE SITE PLAN.






